The Play House (Birmingham) is a registered charity (no. 1034809) and Company Limited by Guarantee (no. 02828276).

We are a Theatre in Education company, delivering high quality creative work for and with children in education settings with a track record of 30+ years.

The Play House (TPH) engages with over fifty schools across Birmingham per year, with an extensive touring programme of workshops and shows which bring the curriculum to life for children.

We are proud to also co-create and deliver bespoke projects for schools and offer high level CPD for teachers. Working collaboratively is important to us and we work with a range of partnerships including The University of Birmingham, Birmingham Arts School and our primary school partners to place drama and imagination at the heart of the learning experience for children.

TPH is led by Jo Sadler-Lovett (Director), with a small team of project specific employees and a wider pool of freelancers.

The annual income for the 2021-2022 financial year was £196,750.00 and TPH has separate ring-fenced reserves for thorough winding up purposes and healthy free reserves to delegate as trustees feel necessary.

The Opportunity

TPH is looking for dynamic and committed individuals to fulfil the role of Chair and to recruit 3 trustees/non-executive directors to join the board.

We are looking for individuals who are:

- willing to embrace the challenging context TPH is operating in whilst bringing fresh energy and exciting vision.
- passionate change-makers; people who embrace challenge and are committed to developing opportunities for children to engage in creative learning.
- able to bring their own connections and relationships to support the strategic development of the company.

This is an exciting time, where individuals will have the opportunity to be a significant influence as TPH refreshes its business plan and strategic position.

You will also get the chance to serve a company making a meaningful contribution the lives of children across the city of Birmingham.

Our usual tenure for board positions is 3 years.



Outline of Role

You will take responsibility for the governance of TPH and ensure the company complies with all statutory and legal requirements, in line with its memorandum and articles of association.

The Chair will have an active role, providing leadership to the board and regularly supporting the Director.

As a Company Limited by Guarantee and as a registered charity, you will have duties under both **company** and **charitable law.**

Specific duties include, but are not limited to:

- Play a key role in developing the overall direction and development of TPH through good governance and clear strategic planning
- Offer sound, objective advice on a regular basis to ensure TPH achieves its objectives effectively and maintains its relevance
- Monitor the risks to the organisation and ensure TPH are putting in steps to manage them



- Publicly advocate for TPH, promoting its work and ethos within your own networks
- Work with the Director and other trustees/NEDs to develop the wider board, including recruiting and on-boarding trustees where required
- Ensure TPH complies with its governing documents, charity law requirements and other relevant legislation and regulations

Chair specific duties:

- Develop a strong and effective working relationship with the Director, including undertaking annual appraisals and offering support as appropriate
- Act as senior safeguarding lead alongside the Director who is Designated Safeguarding Lead
- Ensure sound financial management of TPH and support the preparation of necessary annual accounts
- Effectively setting board agendas in advance and leading TPH board meetings, ensuring they are productive, objective, and compliant

Commitment

The board meet every 8 weeks for around 2 hours. Meetings are a mix of online and in person at TPH offices in Birmingham City Centre.

As the Chair you will be required from time to time to work with the Director outside of board meetings, this is to be negotiated between the Chair and Director.

The role is voluntary, but reasonable travel expenses will be reimbursed in line with Company Policy.
